ORDER:

In the Government Order first read above, the Government ordered that Friday the 1<sup>st</sup> December 2017 as a Government Holiday for Milad-un-Nabi under Negotiable Instruments Act, 1881. The Chief Kazi to Government of Tamil Nadu in his letter 2<sup>nd</sup> read above has stated that the moon was not sighted on 19.11.2017, and that the Milad-un-Nabi (Prophet Mohammed's Birthday) will be celebrated on Saturday the 2<sup>nd</sup> December 2017 and not on Friday, the 1<sup>st</sup> December 2017 and requested to declare the public holiday on Saturday the 2<sup>nd</sup> December 2017.

2. The Government, after careful consideration of the matter, have decided to declare 2<sup>nd</sup> December 2017 as a Public Holiday for Milad-un-Nabi instead of 1<sup>st</sup> December 2017 under Negotiable Instruments Act, 1881. Accordingly, the following Notification will be published in an extra-ordinary Gazette dated 21.11.2017.

NOTIFICATION

Under the Explanation to Section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881) read with Notification of the Government of India, Ministry of Home Affairs No.20-25-26, Public-1, dated 8<sup>th</sup> June 1957 the Government of Tamil Nadu hereby declares that Saturday the 2<sup>nd</sup> December 2017 would be a Public Holiday on account of Milad-un-Nabi instead of 1<sup>st</sup> December 2017.

3. The above Public Holiday notified shall also be applicable to all State Government Undertakings / Corporations / Boards etc.
